

WHAT IS THE PURPOSE OF SCHOOL BILLING?

HOW DO I KNOW WHICH HEALTH SERVICES CAN BE REIMBURSED?

Only health services provided to students who meet the following parameters are eligible for reimbursement from Medicaid:

- The child receiving the service must be enrolled in Medicaid.
- The services are medically necessary.
- The services must be covered in the state Medicaid plan or authorized by the federal Medicaid statute.
- The services must be listed in the child's individualized education program (IEP) or individualized family service plan (IFSP).
- The school district or local educational agency (LEA) must be authorized by the state as a qualified Medicaid provider.
