Our Enterprise Data Warehouse drives sophisticated analytics and stratification engines that transform clinical and claims data into actionable information, resulting in better clinical outcomes and lower cost of care.

Traditional healthcare data warehouse platforms are designed primarily to store post adjudicated claim information and limited clinical data. Lightbeam's healthcare data model and warehouse was designed from the ground up to store more complete, real time clinical information. Additional real time clinical values will allow for dramatic improvements in the accuracy of your risk stratification, enabling your care managers to focus on the right patients at the right time.

#### **Risk Stratification**

Lightbeam's stratification engine calculates each patient's risk acuity based on sophisticated protocols and guidelines. Our focus is not simply based on a patient's medical problems and their historical cost of healthcare, but to utilize our revolutionary predictive modeling algorithms to notify care managers regarding patients at risk of avoidable high cost events such as admissions and ER visits that can be prevented through corrective action. #### Physician Engagement

To effectively manage a patient's health, it is critical that all care givers have a complete understanding of their patient's longitudinal medical profile. 

#### Patient Engagement


The relative health of a population is ultimately driven by the behavior of its patients. It is up to the patient whether they take their medications, exercise, eat right or visit their doctors when they should.

Because patients spend a very small percentage of their waking hours in the care of a physician, it is imperative that we have a window into the health of our patients while at home. The ability to automate the communication process for patients and notifying them they are due for annual wellness visits, preventive, and chronic condition follow-up visits will help improve the overall health of the patient population, satisfy open care gaps and drive fee for service revenue.



Over the next 3 years, up to 80% of your income will be paid by value-based contracts. In your Medicare Advantage plans, the RAF score determines the relative health of your patient population which drives top line revenue. Patient HCC codes are required to be renewed each year, therefore, providers need to be notified of this critical information at the point of care.

Lightbeam notifies the physician of HCC coding gaps at the point of care, ensuring accurate, up to date documentation which will increase the average RAF score for the patient population.



#### GPRO Reporting

Lightbeam's GPRO Module will simplify reporting and enhance MSSP-ACO Quality Measure submission efforts. Our ability to extract data directly from your existing EHR(s) will help automate the completion of open care gaps and satisfy MSSP-GPRO quality measures. Lightbeam then creates the GRPO specific XML format for automated submission to CMS.

Lightbeam's GPRO Reporting Solution displays a measure progress screen which allows users to view progress on all Quality Measures from a summary view, or in ranking order. Additionally, our solution provides the ability to measure progress by practice, provider, specialty and patient to identify performance results at each level.
