I am pleased to announce the General Availability of CGM LABDAQ® ver. 22.1 from CompuGroup Medical.

The key improvements with this release that have been introduced since ver. 21.3 was released in 2021 include:

#### **Gender Support Improvements**

- As various states require labs and EMRs to report on additional gender data (for example where a patient's gender identity is different from their biological gender and both must be captured correctly), CGM LABDAQ has been extensively enhanced to support multiple genders.
  - CGM LABDAQ users can now define their own genders, to accurately reflect a patient gender based on their state or other specific requirements
  - This support matches Medicare requirements
  - This support is extensive throughout CGM LABDAQ, including in:
    - General set up
    - Test, facility, location, rules, and patient set up
    - Reports
    - Importing and exporting

### **Result Flagging Improvements for Priority Results**

- Flag Icons are now provided on panels that contain out of range results to enable staff to see immediately without having to expand each panel
- Panels in Requisition Maintenance are now flagged the same as the test with the highest severity
- Manager Review will also display flags on the panel level

#### Scanned Documents can now be created as PDFs

 Scanned documents can now be created as PDF's through any Attachments section within CGM LABDAQ

### **Control Alert Settings Enhancements**

 Users in a specific user group can now see control alerts for all locations (not just their logged in location)

#### **Performance Enhancements**

 "Maximum Thread Count" has been added to the exporter to help improve the speed of each export

### **Administration Enhancements**



- Four new housekeeping jobs have been added, including: Delete Export History rows over 180 days old, Delete Import Log rows over 180 days old, Delete Dispatch Queue Labels over 7 days old, and Delete Dispatch Queue Reports over 180 days old
- Support menu enhancements
  - The support menu has been moved from the CGM LABDAQ logo to the System Functions section
  - A link to CGM LABDAQ video tutorials has been added
  - Home page tiles can now be created for each item

#### **General Enhancements**

- Sets have been added as criteria for many rules
- Custom badges can be added to panels and tests for easy identification

Specifically for cannabis laboratories:

### Web Services: Signatories

- Users can now choose one of two roles for the person signing the Certificate of Analysis
  - "Run-by User"
  - "Approved-by User"
- o Users can also choose whether to use the signatory's initials or full name

# **Confident Cannabis Signature URL**

 Users can store the Confident Cannabis Signature URL so the user's signature that is kept in Confident Cannabis appears on the Certificate of Analysis

#### Weight on Hand

- o Confident Cannabis can return "Weight on Hand"
  - CGM LABDAQ can be set up to calculate a sample's remaining weight after the amount used for a test is entered

## **In-Progress Orders**

o "In Progress" Status will import from Confident Cannabis

In addition to these enhancements, there are a number of cumulative features that have been delivered throughout multiple versions of CGM LABDAQ. See <u>Appendix A</u>.

Appendix B provides answers to Frequently Asked Questions regarding the recent switch from Oracle to Microsoft SQL Server that we introduced in March of 2020, with CGM LABDAQ ver. 20.1.
